- 3. A member entitled to attend and vote at the Meeting is entitled to appoint one or more proxies to attend and vote (on show of hand and on a poll if a proxy is appointed, however, if more than one proxy is appointed, by poll only) on his behalf. A proxy need not be a member of the Company. If any proxy other than the Chairman is preferred, strike out "the Chairman of the Meeting or" herein inserted and insert the name(s) and address(es) of the proxy/proxies desired in the space provided. ANY ALTERATION MADE TO THIS FORM OF PROXY MUST BE INITIALLED BY THE PERSON WHO SIGNS IT.
- 4. IMPORTANT: IF YOU WISH TO VOTE FOR ANY RESOLUTIONS, TICK "\" THE APPROPRIATE BOXES MARKED "FOR", IF YOU WISH TO VOTE AGAINST ANY RESOLUTIONS, TICK "\" THE APPROPRIATE BOXES MARKED "FOR", IF YOU WISH TO DID taken at the Meeting, a shareholder (including his proxy/proxies) entitled to two or more votes need not cast all his votes in the same way. Failure to complete any or all the boxes will entitle your proxy to vote or abstain at his discretion. Your proxy will also be entitled to vote at his discretion on any resolution properly put to the same Meeting other than those referred to in the Notice convening the Meeting.
- 5. Ordinary Resolution shall be passed by an affirmative vote of more than half of the Company's total voting shares being held by the shareholders present at the general meeting (including proxies).
- 6. This form of proxy must be signed by you or your attorney duly authorised in writing, or, in the case of a corporation, must be either under its common seal or under the hand of an officer or attorney duly authorised. Only one of the joint holders needs to sign.
- 7. In the case of joint holders, the vote of the senior who tenders a vote, whether in person or by proxy, shall be accepted to the exclusion of the votes of the other joint holder(s). For this purpose, seniority shall be determined by the order in which the names stand in the Register of Shareholders in respect of the joint holding.
- 8. To be valid, this form of proxy, together with any power of attorney (if any) or other authority (if any) which it is signed or a notarially certified copy thereof, must be deposited at the share registrar of the Company in Hong Kong at Hong Kong Registrars Limited of Rooms 1806-7, 18/F., Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong (for H shares) or the Company's registered office (for domestic shares) not less than 24 hours before the time scheduled for the commencement of the Meeting or any adjournment thereof.
- 9. Completion and delivery of the form of proxy will not preclude you from attending and voting at the same Meeting of the Company if you so wish.
- 10. The H Shares register of shareholders of the Company will be closed from Tuesday, 20 May 2008 to Thursday, 19 June 2008 (both days inclusive), during which no transfer of the Company's H Shares will be effected. The holders of Shares whose names appear on the register of shareholders of the Company at 4:00 p.m. on Monday, 19 May 2008 will be entitled to attend and vote at the Meeting.
- 11. Voting for the ordinary resolutions set out in the notice will be taking by poll.
