The EGM has been held at the Conference Room of the 12th Floor, Quantum Silver Plaza, 23 Zhichun Road, Haidian District, Beijing, the People's Republic of China on Thursday, 13 December 2007. A poll has been demanded by the chairman of the Company for voting on the proposed resolutions as set out in the Notice of the EGM which has been delivered to all the Shareholders, and the resolutions have been approved by the Shareholders by way of poll.

As at the date of the EGM, the Company has issued a total of 2,898,086,091 Shares, comprising 2,123,588,091 Domestic Shares and 774,498,000 H Shares. The total number of issued Shares of the Company entitling holders to attend and vote for or against the resolutions at the EGM are 2,898,086,091.
